# 1. **INTRODUCTION**

- 1.1 EasyEquities is running a lucky draw competition (the "**Capitec Easy Investing Competition**") for (i) all persons who complete their registration for an EasyEquities account on the Capitec widget found on the Capitec banking application (the "**Widget**") and post their first investment on Twitter or Facebook using the #CapitecEasyEquities hashtag and tagging @EasyEquities, @YFM, and @CapitecBankSA during the Competition Period (defined below), and (ii) for EasyEquities account holders who have registered but not funded their EasyEquities account via the Widget prior to the Competition Period and who fund their EasyEquities account during the Competition Period.
- 1.2 The Capitec Easy Investing Competition is subject to the terms and conditions set out below and is subject to and must be read together with the EasyEquities Terms and Conditions.
- 1.3 The clauses in these terms and conditions that require your careful consideration are in **bold** font. You acknowledge that you have read and appreciated the importance of the terms and clauses in **bold** font.
- 1.4 Capitalised terms used but not defined herein will have the same meaning as in the EasyEquities Terms and Conditions.
- 1.5 By participating in the Capitec Easy Investing Competition, you agree to be bound by these terms and conditions.

# 2. HOW TO QUALIFY FOR THE CAPITEC EASY INVESTING COMPETITION

- 2.1 Subject to clause 2.2 below, in order to be entered into the Capitec Easy Investing Competition, you must:
  - (1) register for an EasyEquities account via the Widget during the Competition Period; and
  - (2) post to Twitter or Facebook regarding your first investment using the #CapitecEasyEquities hashtag tagging @EasyEquities, @YFM, and @CapitecBankSA during the Competition Period (hereinafter referred to "Category 1 Entrants"); or
  - (3) have registered but not funded your EasyEquities account via the Widget prior to the Competition Period; and
  - (4) fund your EasyEquities account during the Competition Period (hereinafter referred to "Category 2 Entrants").
- 2.2 Only EasyEquities accounts that have been approved for Trading by EasyEquities in accordance with the EasyEquities Terms and Conditions, including without limitation, verification in terms of the Financial Intelligence Centre Act, 2001 ("**FICA**") will qualify for the Capitec Easy Investing Competition. # 4. TICKETS IN THE DRAW AND WINNER SELECTION

- 4.1 Each EasyEquities ZAR account holder who meets the eligibility requirements set out in clause 2 above will earn one entry into the Capitec Easy Investing Competition.
- 4.2 The Capitec Easy Investing Competition closes at 23h59 on 31 July 2022.
- 4.3 In respect of Category 1 Entrants, one winner will be randomly selected on a weekly basis during the Competition Period. The winners will be announced on YFM's the A-list radio show which airs between 9am and 12pm on weekdays.
- 4.4 In respect of Category 2 Entrants, one winner will be randomly selected from the group of entrants each Friday (excluding Friday, 1 July 2022) during the Competition Period using an electronic random name generator.
- 4.5 The weekly winners of the Capitec Easy Investing Competition will receive a R10 000.00 EasyEquities voucher which will be automatically deposited into their EasyEquities ZAR account.

(each a "Prize," collectively "Prizes").

- 4.6 Each Category 1 Entrant will each receive a R50.00 EasyEquities voucher which will automatically be deposited into their EasyEquities ZAR account (the "**Voucher**") when they register for an EasyEquities account.
